I, KATE ELLEN COLLINGWOOD the Wife of Horatio Nelson Collingwood of "Ryst Wood House" Forest Row in the County of Sussex Gentleman HEREBY REVOKE all former Wills and Codicils made by me and declare this to be my last Will

1. I APPOINT my Son Arnold Nelson Collingwood and my Daughter Kathleen Edith Collingwood both of "Ryst Wood House" aforesaid to be the Executor, Executrix and Trustees of this my Will.

2. I DECLARE that in the interpretation of this my Will the expression "my Trustees" shall (where the context permits) mean and include the Trustees or Trustee for the time being hereof whether original or substituted and if there shall be no such Trustees or Trustee shall (where the context permits) include the persons or person empowered by statute to exercise or perform any power or trust hereby or by statute conferred upon the Trustees hereof and willing or bound to exercise or perform the same

- 3. I BEQUEATH the following pecuniary legacies :-
 - (a) To my Godson Thomas Eaton Cowx of The Vicarage, Rosedale in the County of York One hundred pounds
 - (b) To Marion Cowx of Moorlands, Baldrine in the Isle of Man One hundred pounds
 - (c) To my Sister Emily Maud Scoby Smith the Wife of William Scoby Smith One hundred pounds

AND I DECLARE that the foregoing legacies shall be paid free of all legacy duty and all other (if any) duties payable upon or by reason of my death

4. I GIVE DEVISE AND BEQUEATH all my real and personal estate whatsoever and wheresoever not hereby or by any Codicil hereto otherwise specifically disposed of unto my Trustees UPON TRUST to sell call in and convert the same into money (subject to the Clause empowering my Trustees to postpone such sale calling in and conversion hereinafter contained) and out of the clear moneys to arise from such sale calling in and conversion as aforesaid and out of my ready money to pay my debts funeral and testamentary expenses and to stand possessed of the residue thereof and of any part of my Estate for the time being unsold (hereinafter called my Residuary Estate) UPON TRUST as to both Capital and Income to divide the same between my said Son Arnold Nelson Collingwood and my said Daughter Kathleen Edith Collingwood in equal shares PROVIDED ALWAYS that if either of my said Son and Daughter shall die in my lifetime leaving issue living at my death such issue shall take equally amongst themselves if more than one on arriving at the age of twenty one years the share to which his her

or their deceased parent would have taken if living AND ALSO PROVIDED that if either of my said Son and Daughter shall die in my lifetime without leaving issue living at my death then the share to which such Son or Daughter predeceasing me would have been entitled if living shall accrue to and be held in trust for the survivor of them absolutely AND ALSO PROVIDED that if both my said Son and Daughter shall die in my lifetime without leaving issue living at my death then my Trustees shall stand possessed of my Residuary Estate UPON TRUST to divide the same equally between the following persons, namely :-

- (a) My Nephew Edgar Arnold Eaton of 4a Fulwood Park Liverpool in the County of Lancashire Commercial Manager
- (b) My Niece Margaret the Sister of the said Edgar Arnold Eaton
- (c) My Nephew Jack Eaton the Son of my late Brother Arthur Frank Eaton
- (d) My Niece Madge Stead the Wife of Yeoman Stead of Northallerton in the said County of York
- (e) My Niece Gertrude Stobbs the Wife of Kenneth Stobbs of Darlington in the County of Durham Farmer
- (f) The said Thomas Eaton Cowx and
- (g) The said Marion Cowx

or such of the same as shall be living at the date of my death Provided that if any of the said Edgar Arnold Eaton, Margaret the Sister of the said Edgar Arnold Eaton, Jack Eaton, Madge Stead, Gertrude Stobbs, Thomas Eaton Cowx and Marion Cowx shall die in my lifetime leaving issue who shall be living at the date of my death such issue shall take equally between themselves (if more than one) the share of my Residuary Estate which his her or their parent would have taken if he or she had survived me and attained a vested interest

5. I DECLARE that my Trustees may postpone the sale calling in and conversion of any part of my real or personal estate for such period as they may in their absolute discretion deem fit without being answerable for any loss occasioned thereby and in particular they may retain any shares in Collingwood & Son Ltd. or other investments of which I may be possessed at the time of my death
